Asbestos Service Category – Description

Asbestos Refurbishment and Demolitions Surveys (Asbestos R&D Surveys)

A refurbishment and demolition survey is needed before any refurbishment or demolition work is carried out. This type of survey is used to locate and describe, as far as reasonably practicable, all asbestos containing materials in the area where the refurbishment work will take place or in the whole building if demolition is planned. The survey will be fully intrusive and involve destructive inspection, as necessary, to gain access to all areas, including those that may be difficult to reach. A refurbishment and demolition survey may also be required in other circumstances, e.g. when more intrusive maintenance and repair work will be carried out or for plant removal or dismantling. **Asbestos refurbishment and demolition surveys will be required for all work which disturbs the fabric of the building in areas where the management survey has not been intrusive.**

Project Management

For all asbestos work the appropriate level of planning and supervision must be in place. A Project Manager in this case will liaise closely with the asbestos duty holder and client to formulate a scope of works and methodology to carry out any work on asbestos materials within health and safety guidelines. The project manager will manage the Sheffield City Council processes and all sub contractors to ensure work is carried out to the required standard. Lower risk asbestos materials may not need the involvement of a Project Manager but will still need to be carried out to the same Sheffield City Council processes and health and safety guidelines.

Analytical Services

Asbestos removal and remedial work may require a qualified and competent person to provide air monitoring and personal monitoring during the work providing clearance and reoccupation certificates as required by the Health and Safety Executive.

Asbestos Management Surveys

An asbestos management survey is the standard survey. Its purpose is to locate, as far as reasonably practicable, the presence and extent of any suspect asbestos containing materials in the building which could be damaged or disturbed during normal occupancy, including foreseeable maintenance and installation, assess their condition and risk. Asbestos management surveys will involve a sampling to confirm asbestos is present.

Asbestos Removal & Remedial Works

Qualified and competent persons or companies licensed to physically work on or remove asbestos to Health and Safety guidelines. Sheffield City Council processes dictate that asbestos removal companies cannot work without the appropriate level of supervision being in place.

Licensed Asbestos Removal

Qualified and competent persons or companies licensed to physically work on or remove asbestos to health and safety guidelines. Sheffield City Council processes dictate that asbestos removal companies cannot work without the appropriate level of management and supervision being in place.
